## **COMMUNICATIONS**

1. WCWSA Rate Adjustment: Letter was received from the Wayne County Water and Sewer Authority notifying the town of the proposed water rate adjustment for 2007. "As of January 1<sup>st</sup>, 2007 the cost of water within the Western Wayne Service Area...will be \$3.75 per thousand gallons purchased. This reflects an increase of \$0.10 per thousand gallons from the 2006 rate. Also, there will be an increase in the basic service charge from \$12.50 per quarter to \$15.00 per quarter. Customers will be notified of the rate increase...."

WCWSA WATER RATE ADJUSTMENT FOR 2007

 Resignation of Deputy Town Clerk: Letter was hand delivered on November 6<sup>th</sup> to the Town Clerk's office with the resignation of Deputy Town Clerk Betsy Lewis, effective as of that date. The resignation includes her appointments as Deputy Town Clerk, Deputy Registrar, Records Management Coordinator and Website Manager.

#### REPORTS OF STANDING COMMITTEES

## **Buildings and Grounds Committee – Ken Miller, Chairman**

Town Hall Roof Gutters installation: Ken Miller updated the town board on the status of the roof gutter installation on the back side of Town Hall. He had contacted Monroe Insulation and Gutter (MIG) to let them know the board had approved their bid for installing back roof gutters. Their original estimate of availability late November had been changed to mid-December. The other contract bidder, Proctor Roofing-Contractors is available right away. Ken made the motion to hire Proctor Roofing at a cost of \$800.00, being only \$5 over the MIG bid. Although consensus of the board last month was to proceed with Proctor Roofing, Ken felt it was correct to put the change to a vote.

MTN: APPROVE FIRE DEPARTMENT CONTRACTS WITH ALL 3  Fire Department Contract Renewals with Town: Agreements have been reached with Palmyra Fire Department, East Palmyra Fire Department and Port Gibson Fire Department to renew their contracts for another two years. Mike Lambrix made one motion to approve all three agreements.

Second: Dave Nussbaumer Vote: 4 ayes. Carried.

The 2007-2008 contract with the Palmyra Fire Department is included with these minutes as Attachment B. The 2007-2008 contract with the East Palmyra Fire Department is included with these minutes as Attachment C. The 2007-2008 contract with the Port Gibson Fire Department is included with these minutes as Attachment D.

MTN: TOWN BOARD DOESN'T OBJECT TO PORT GIBSON FIRE DEPT. PURCHASE OF FIRE TRUCK 2. Special Letter Needed for Port Gibson Fire Department: In order for the Port Gibson Fire Department to purchase a fire truck, they need a statement from the Town Board letting the IRS know that they are tax exempt and have no financial obligations to the town. Mike Lambrix made the motion affirming that the town board has no objection to this purchase, and that there are no financial obligations with the town that should hinder the purchase.

Second: Dave Nussbaumer Vote: 4 ayes. Carried.

MTN: ACCEPT RESIGNATION OF BETSY LEWIS AS DEPUTY TOWN CLERK, DEPUTY REGISTRAR, RECORDS MANAGEMENT COORDINATOR & WEBMASTER

3. Resignation of Deputy Town Clerk: In accordance with Betsy Lewis's request in her letter of resignation, Mike Lambrix made the motion to accept her resignation from the positions of Deputy Town Clerk, Deputy Registrar, Records Management Coordinator and Webmaster.

Second: Ken Miller Vote: 4 ayes. Carried.

4. Appoint Deputy Town Clerk, Deputy Registrar and Webmaster: With the resignation of Betsy Lewis as Deputy Town Clerk, including her appointments as Deputy Registrar and Webmaster, it was necessary to appoint her replacement. Mike Lambrix made the motion to appoint Irene Unterborn as Deputy Town Clerk, for 30 hours per week, at a pay rate of \$12 per hour.

MTN: APPOINT DEPUTY TOWN CLERK

Second: Dave Nussbaumer Vote: 4 ayes. Carried.

A second motion was offered by Mike Lambrix to appoint Irene Unterborn as Deputy Registrar.

MTN: APPOINT DEPUTY REGISTRAR

Second: Ken Miller Vote: 4 ayes. Carried.

A third motion was offered by Mike Lambrix to appoint Bill Unterborn as Webmaster.

MTN: APPOINT WEBMASTER

Second: Dave Nussbaumer Vote: 4 ayes. Carried.

5. Cooperative Funding Agreement with WCWSA: Agreement was reached between the towns of Marion, Arcadia and Palmyra with the Wayne County Water and Sewer Authority (WCWSA), for improvements to the water system servicing the three towns, for better flows from town to town, as well as secondary water sources. Each town had previously received grant funding for water projects through the Rural Development Division of the U.S. Department of Agriculture. When water projects were completed, there were unused grant funds. Supervisor Lyon explained that this agreement allows for the three towns to access these unused funds for needed improvements to the water system, thus benefiting the residents of all three towns. Mike Lambrix made the motion to approve the Cooperative Funding Agreement with the WCWSA.

MTN: APPROVE COOPERATIVE FUNDING AGREEMENT WITH MARION, ARCADIA AND WCWSA

Second: Dave Nussbaumer Vote: 4 ayes. Carried.

A copy of the Cooperative Funding Agreement with WCWSA is included as Attachment E.

6. Check Signing for the Town: In order to be able to take advantage of new online banking programs, it would be necessary to change town policy to allow either the Supervisor or Deputy Supervisor to sign checks without requiring a second signature from the Town Clerk or Deputy Town Clerk. Mike Lambrix made the motion to approve this change in town policy.

MTN: CHANGE TOWN CHECK SIGNING POLICY TO ALLOW FOR ONE SIGNATURE

Second: Ken Miller Vote: 4 ayes. Carried.

MTN: ADOPT 2007 TOWN BUDGET 7. <u>Adopt 2007 Preliminary Town Budget:</u> Dave Nussbaumer made the motion to approve the Preliminary Town Budget as amended in the Public Hearing (See Attachment A for final changes).

Second: Mike Lambrix Vote: 4 ayes. Carried.

With the adoption of the Preliminary Town Budget, it becomes the Final Town Budget for 2007.

MTN: ADJOURN MEETING 8. Adjournment: Mike Lambrix made the motion to adjourn at 7:48 p.m.
