RESOLUTION #14-2022 TO SET PUBLIC HEARING – LOCAL LAW #1-2022 A LOCAL LAW AMENDING LOCAL LAW NO. 2 OF 2013 PROVIDING FOR THE ADMINISTRATION AND ENFORCEMENT OF THE NEW YORK STATE UNIFORM FIRE PREVENTION AND BUILDING CODE AND NEW YORK STATE ENERGY CONSERVATION CONSTRUCTION CODE

WHEREAS, the New York Department of State has promulgated updated regulations regarding minimum standards for administration and enforcement of the Uniform Fire Prevention and Building Code ("Uniform Code") and Energy Conservation Construction Code ("Energy Code") (19 NYCRR Part 1203); and

WHEREAS, New York Executive Law § 381(2) requires local governments to update their local code enforcement regulations to be consistent with the aforementioned Part 1203 updates; and

WHEREAS, a copy of such proposed local law is on file with the Town Clerk; and

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Palmyra that a Public Hearing shall be had on the 27th day of October, 2022, at 7:00 P.M., for the purpose of adopting Local Law #1-2022, a local law amending Local Law No. 2 of 2013 providing for the administration and enforcement of the Uniform Code and Energy Code; and be it further

RESOLVED, that the Town Clerk advertise for said Public Hearing in a manner consistent with law; and be it further

RESOLVED, that the Town Clerk cause a copy of the proposed Local Law to be sent to Wayne County Planning and Development for its review pursuant to General Municipal Law Section

3. Approve: Approve Supervisor to Sign Contract with K & D Disposal for Court Ordered Clean up at 2351 Lyon Rd: Todd Pipitone made the motion to approve supervisor to sign contract with K&D Disposal for Court Ordered Clean-up at 2351 Lyon Rd, after town attorney approval, not to exceed \$75,000.00, and to be completed by October 31, 2022. The Town Clerk asked if the contract should be changed to reflect that not only completion was to be by October 31st, 2022, but that the invoice needed to also be received by November 1st, 2022. Supervisor felt that the word "completion" in the contract covered that.
