Minutes of a meeting of the Town Board held in the Justice Room, Village Hall on Tuesday, April 5th, 1905, duly called by the Supervisor. Present: R. N. Backus, Supervisor; R. H. Barehaus, Town Clerk; M. C. Finley, J. M. Sutphen, C. H. Clark, and C. F. Griswold, Justices; and C. H. Hedden, Highway Commissioner.

Supervisor Backus called the meeting to order.

On motion made by Justice Finley and seconded by Justice Griswold, the Supervisor, Town Clerk, and Highway Commissioner were empowered to make a contract with the Buffalo Pitts Steam Roller Company of Buffalo to lease a steam roller for use in the Town of Palmyra. Unanimously carried.

Minutes of a special meeting of the Town Board held in the Justice Room, Village Hall on April 28th, 1905. Present: R. N. Backus, Supervisor; R. H. Barehaus, Town Clerk; M. C. Finley, J. M. Sutphen, C. F. Griswold, and E. H. Clark, Justices.

Meeting was called to order by Supervisor Backus in the chair.

On motion, seconded and carried, Thomas L. Cook was appointed Assessor to fill the vacancy caused by the death of S. W. Sawyer.

On motion by Justice Finley and seconded by Justice Clark, the compensation of the Highway Commissioner be Two Dollars and Fifty Cents (\$2.50) per day from the 1st day of May to the 1st day of November for the year 1905. Carried.

On motion, the Supervisor, Clerk, and Justice Griswold were appointed a committee to provide a suitable place to shelter the road machinery of the Town. Carried.

On motion, seconded, and carried that the Town of Palmyra purchase seven Highway Manuals for use of each member of the Town Board and Highway Commission.

Minutes of a meeting of the Town Board held in the Justice Room, Village Hall on May 5th, 1905. Present: R. N. Backus, Supervisor; R. H.

Supervisor Backus called the meeting to order.

On motion by Justice Griswold and seconded by Justice Clark that the Supervisor pay James Malcomb of Marion and is hereby instructed the sum of \$45.00 from the Road and Bridge Fund for services on the Marion Road.

By Justice Finley: Resolved that we set aside for the several roads of the town the amount of \$35.00 per mile for the maintenance and improvement of the several roads amounting to about the sum of \$1925.00.

That we set aside for the improvement of roads leading from Palmyra to Marion the sum of \$100.00 per miles for four miles of \$400.00.

That we set aside for the improvement of the road from the Palmyra NY Central Station east to the town line the sum of \$100.00 per mile amounting to \$900.00.

That we set aside for the improvement of the highway known as the Walker Road the sum of \$100.00 per mile amounting to about \$400.00

Resolved that we reserve in the Road Fund, the sum of \$900.00 to be expended as we may hereafter agree and determine. The above was copied in an agreement and signed by the Board and Highway Commissioners and sent to Albany.

No further business appearing, the meeting adjourned.

The undersigned, Niagara, Lockport, and Ontario Power Company, a corporation duly organized under the law of the State of New York, hereby makes application to the honorable Town Board and Commissioners of Highways of the Town of Palmyra, Wayne County, New York, for permission and consent to construct, maintain, and operate the necessary poles, towers, wires, cables, conduits, subways, appliances, and structures in, through, upon, or under all of the streets, alleys, and public ways of the Town of Palmyra for the purpose of using, distributing, and furnishing electricity for light and heat to the said Town of Palmyra and the inhabitants thereof.

John Pallace, Jr. appeared for the Niagara, Lockport, and Ontario Power Company and spoke in favor of granting the application.

Mr. Finley offered the following resolution and moved its adoption: Whereas, Niagara, Lockport, and Ontario Power Company, a corporation duly organized under and by virtue of the laws of the State of New York, has made application in writing to the Town Board and Commissioners of Highways of the Town of Palmyra, Wayne County, New York, for permission and consent to construct, maintain, and operate the necessary, poles, towers, wires, cables, conduits, subways, appliances, and structures in, through, under, and across the streets, highways, alleys, and public ways of the Town of Palmyra, Wayne County, New York, for the purpose of using, distributing, and furnishing electricity for light, heat, or power to the said Town of Palmyra and the inhabitants thereof, and

Whereas, said application has been duly considered; now, therefore, resolved that permission and consent; and they are hereby granted to

Niagara, Lockport, and Ontario Power Company, its successors, lessees, and assigns to construct, maintain, and operate the necessary poles, towers, wires, cables, conduits, subways, appliances, and structures in, through, upon, under, and across all of the streets, alleys, and public ways of the Town of Palmyra for the purpose of using, distributing, and furnishing electricity for light, heat, or power to the said Town of Palmyra and the inhabitants thereof. Such consent and permission being granted upon and subject to each and all of the following terms and conditions:

1st – Said Niagara, Lockport, and Ontario Power Company, its successors, lessees, or assigns shall at all times save and keep harmless and fully indemnify the said Town of Palmyra, its officers, and agents from any and all loss, liability, and damages and will pay to the said Town of Palmyra all damages which it shall sustain in any manner arising from the construction, maintenance, use, or operation of said poles, towers, wires, cables, conduits, subways, appliances, or other structures, or from any negligence, fault, or misconduct on the part of the said Niagara, Lockport, and Ontario Power Company, its successors, lessees, or assigns or its agents, servants of employees, and from any failure on its part to observe and comply with the conditions of this instrument.

2nd: All poles, towers, wires, cables, conduits, subways, appliances, structures, and erections of every kind in, upon, under, or across any street, highway, alley, or public way shall at all times be kept and maintained in a safe, suitable, and substantial condition and in such good order and repair as shall be directed or approved by the Town Board. All poles at any time in use unless made of iron or steel shall be of first quality pine or cedar erected and maintained in each case at such point as shall least obstruct the streets or interfere with their usefulness and shall be placed in every instance with reference to any poles or structures now existing in any of the streets, highways, alleys, or public ways. Said poles shall be erected at least one hundred feet apart, except where necessary to support and carry cables and wires around the corners of streets. They shall be safely and firmly erected, properly shaped and finished, and painted such color as shall be directed by the Town Board. They shall be at least twenty-five feet in height above the level of the ground and shall be of uniform size—either octagon or circular in form. The wires and cables shall be placed and maintained at a safe and suitable distance from the ground, not less than twenty feet. They shall be properly insulated where fastened to poles or towers in such manner as to prevent the escape of the electric current.

3rd: Materials delivered on the streets shall be required to be piled neatly on the front of the sidewalks, not less than three feet from any fire hydrant and in such manner as will preserve a passageway of at least three feet on the line of the sidewalk, travel upon the streets or upon any intersecting street or alley shall not be hindered or inconvenienced

needlessly nor shall the same be obstructed completely without permission from the Town Board.

4th: Work shall be done with the utmost reasonable promptness and dispatch at each point and the street restored to as good condition in all respects as it was before being disturbed; and all dirt, refuse, and unused material immediately removed.

5th: Upon the application in writing of the owner or occupant of any building or premises within four hundred feet of any service wire of the Niagara, Lockport, and Ontario Power Company in the Town of Palmyra, and payment by him of all money due from him to the corporation, the corporation shall supply electricity for light, heat, power, or any other purpose as may be required at prices not exceeding the following rates:

For lamps, twelve cents per kilowatt hour, with a discount of two cents per kilowatt hour if the bill is paid on or before the 15th day of the month following that for which the bill is rendered, except that no bill shall be rendered for no less than one dollar per month.

For power, heat, or any other purpose except lighting, a service charge of one dollar per month per kilowatt capacity installed shall be paid for maximum power called for, and the following sums for the amount of electricity actually used monthly according to meter measurements.

For 1000 kilowatts or less per month \$.04 per kilowatt hour;

For excess over 1000 kilowatts up to 2000 kilowatts per month \$.03 per kilowatt hour;

For excess over 2000 kilowatts up to 3000 kilowatts per month \$.02 per kilowatt hour;

For excess over 3000 kilowatts up to 5000 kilowatts per month \$.01 per kilowatt hour;

For excess over 5000 kilowatts up to 10,000 kilowatts per month \$.008 per kilowatt hour;

For excess over 10,000 kilowatts up to 20,000 kilowatts per month \$.0075 per kilowatt hour;

For excess over 20,000 kilowatts up to 40,000 kilowatts per month \$.007 per kilowatt hour;

For excess over 40,000 kilowatts up to 80,000 kilowatts per month \$.0066 per kilowatt hour;

For excess over 80,000 kilowatts per month \$.0064 per kilowatt hour.

Electricity shall be measured by watt meter of standard manufacture.

After the construction of any service wire in, through, upon, or under any of the streets, highways, alleys, or public ways of the Town of Palmyra; and if for the space of ten days after such application and the deposit of a reasonable sum of money according to the amount of electricity required as security for the payment of the same, the corporation shall refuse or neglect to supply electricity for light, heat, power, or any other purpose as required, such corporation shall forfeit and pay to the applicant the sum of \$10, and the further sum of \$5 for every day thereafter during which such refusal or neglect shall continue.

6th: This permission and consent shall be duly accepted by an instrument in writing, executed, and acknowledged by the Niagara, Lockport, and Ontario Power Company within thirty days after the same has been duly adopted, which said acceptance shall be filed with the Town Clerk of the Town of Palmyra.

Overseer of the Poor, A. C. Hopkins, presented his report for 1905; and upon examination, was found correct. Showing disbursements of \$1676.25; receipts 1662.29; overdrawn at the bank \$14.96.
