Of Highways having read estimates from Bridge Manufactures and giving the testimony of Bridge experts that the two bridges over Mud creed were unsafe it was resolved that the voters of the Town of Palmyra at the next Town election make an appropriation or tax against said town for the following purposes, viz.

\$5200 for the construction of two Iron Bridges and abutments over Mud Creek one at or near the N.Y.C. Depot the other at or near the W.S. and B. Depot at \$800 for the support of the Poor. On motion Board adjourned

The entire Board being present at the adjourned meeting Saturday Mar. 1<sup>st</sup> proceeded to examine Mr. Flower, Overseer of the Poor books, and vouchers which were found satisfactory and \$374.58 to be on hand on motion Board adjourned.
