<u>Town of Palmyra – Minutes for 1907</u>

Minutes of a meeting of the Town Board held at the Village Hall on Saturday, January 19, 1907. Present: R. N. Backus, Supervisor; M. c. Finley, E. H. Clark, C. F. Griswold, and J. M. Sutphen, Justices; and H. L. Averill, Clerk.

Meeting was called to order by Supervisor R. N. Backus; and minutes of previous meeting were read and approved.

B. W. Farnham, Engineer and Attorney McFarlane representing the New York Central Railroad appeared before the Board and asked permission to change the grade of the West Shore tracks where the same cross three highways in the town of Palmyra; and after the matter had been thoroughly discussed, the following resolution was offered and adopted: Resolved, that consent be, and the same hereby is given, too the New York Central and Hudson River Railroad Company to change the grade of its West shore tracks where the same crosses Palmer's Highway (No. 428) in said town, by raising said tracks about one and three tenths (1.3) feet above their present level; also to change the grade of its West Shore tracks where the same crosses Port Gibson Highway (No. 429) in said town, by raising them about seventy-five hundredths (0.75) feet above the present level; also to change the grade of its West Shore tracks, where the same crosses Galloway's highway (No. 430) in said town, by raising them about three and two tenths (3.2) feet above the present level.

The said Railroad Company to make the approaches to said tracks as so changed, not more than a six percent (6%) grade from the present level of the highways to the level of the tracks as so raised, and to properly surface said approaches and the part of the highway so changed by it with sand, gravel, or other good road making material.

On motion, it was voted to hold the regular meetings of the Board on the third Saturday of each month, instead of the third Friday until further resolution.

On motion, Supervisor Backus was empowered to take \$125 from the General fund and add to the Highway Fund.

No further business appearing, the meeting adjourned.

Harry G. Chapman, representing the Cator Dump Wagon, appeared before the Board in the interest of the company and asked the Board to purchase one or two Cator Dump Boxes for work on the highways; and after a thorough discussion, a resolution was unanimously passed authorizing the Board to purchase two Cator Dump Boxes, if the same were recommended by Highway Commissioner Hedden.

Meeting of the town board of Palmyra held at the Village Hall on Saturday afternoon, March 16, 1907. Present: R. N. Backus, Supervisor; M. C. Finley, E. H. Clark, J. M. Sutphen, and C. F. Griswold, Justices of the Peace; C. H. Hedden, Highway Commissioner; and H. L. Averill, Clerk.

Meeting called to order by Supervisor Backus, and minutes of last meeting read for information.

Mr. Pliny T. Sexton appeared before the Board in relation to back taxes on the G. R. Brown property on Fayette Street; and on motion, a resolution was passed appointing a committee consisting of Backus, Finley, and Clerk to investigate the said tax question and report at the next meeting.

Mr. Backus reported that Mr. Hedden, the Highway Commissioner, had recommended the purchase of two Cator Dump Wagons according to a resolution adopted at the last meeting, and the order for the machines had been given.

On motion of Mr. Averill, a resolution was passed authorizing the Highway Commissioner to expend the sum of \$35 per mile for fifty miles of road throughout the township the coming year.

On motion of Mr. Griswold, a resolution was passed authorizing the expending the sum of \$700 for four miles of road on the Town Line or Spur Road.

On motion of Mr. Finley, a resolution was passed authorizing the expenditure of \$200 for one-fourth mile of road on the Marion-Palmyra Road north from Central Station.

On motion of Mr. Griswold, a resolution was passed authorizing the expenditure of \$300 for three miles of road on the Jeffery Road.

On motion of Mr. Finley, a resolution was passed authorizing the expenditure of \$400 on the Vienna Road.

No further business appearing, the minutes of the meeting were read and approved; and the meeting adjourned.

On motion of Mr. Griswold, the committee appointed to investigate the claim of Pliny T. Sexton for back taxes on the G. R. Brown property was discharged.

On motion of Mr. Finley, a resolution was passed leaving the matter of investigating the Sexton tax claim to Supervisor Backus with power to act.

The minutes of the meeting were read and approved, and the meeting adjourned.

The committee appointed to confer with New York Central Engineers and the Village Board regarding the corporation boundary near the Central Station made necessary by the changing the course of Mud Creek reported that the boundary lines had been settled upon, and that the same had been made plain with steel markers at the expense of the Central Railroad Company.

State Board of Health Albany, NY

Gentlemen:

The Town Board of Health of the Town of Palmyra this afternoon received the resignation of Dr. L. B. Darling as Health Officer for this township. The Board did not take any action in the matter, waiting until it could hear from your department. The Board will, however, recommend the resignation being accepted and that Dr. William J. Hennessy, who is now serving as Village Health Officer, being named as his successor.

In the judgment of the department, would not Dr. Darling have to look after the cases now in his hands until his successor's appointment can be confirmed? Please advise the Board in this matter.

On motion of Mr. Griswold, a resolution was passed authorizing C. C. Congdon, attorney, to see to the collection of the delinquent poll taxes with power to prosecute where necessary.

On motion of Mr. Griswold, a resolution was passed authorizing the Highway Commissioner to publish a suitable notice to cut weeds along the highways in each of the village papers three weeks.

No further business appearing, the minutes were read and approved, and the meeting adjourned.

Meeting of the Town Board held at the Village Hall on Saturday, December 28, 1907, for the purpose of settling accounts of town officers and for the transaction of such other business as might properly come before the meeting. Present: R. N. Backus, Supervisor; C. F. Griswold, M. C. Finley, E. H. Clark, and J. M. Sutphen, Justices; and H. L. Averill, Clerk.

The meeting was called to order by Supervisor Backus, and minutes of last meeting read for information.

On motion of Mr. Finley, a resolution was passed authorizing the payment of the town's share of the purchase of formaldehyde by the Health Officer amounting to \$7.71.

The accounts of Highway Commissioner Hedden were gone over, and on motion a resolution was passed approving them.

The accounts of Supervisor Backus were examined and found to be correct; and on motion of Averill, a resolution was passed approving his report.

On motion of Mr. Finley, a resolution was passed authorizing the Supervisor to draw a check in payment of C. Belty's bill for sheep killed by dogs amounting to \$41.00

A resolution was offered by Mr. Griswold and duly carried, instructing Attorney C. C. Congdon not to prosecute poll tax in cases where delinquents can show a certificate of exemption, firemen's certificate, or over seventy years of age.

On motion of Mr. Finley, a resolution was passed fixing the amount of the supervisor's bond to be the same as the last two years: \$10,000.

On motion of Mr. Averill, a resolution was passed accepting the report of Overseer of the Poor, A. C. Hopkins.

On motion of Mr. Clark, a resolution was passed authorizing the clerk to appoint a committee of one to draft suitable resolutions on the retirement of Supervisor Backus and the same to be spread upon the records of the town.

The Clerk appointed Mr. Clark; and he offered the following resolutions, which were unanimously adopted:

"In view of the retirement of Rufus N. Backus from office as Supervisor of Palmyra, we, the members of the Town Board of said town, desire to express our sentiments as follows:

"We thank Mr. Backus for many favors received at his hands. We are sorry to part with so wise a counselor and so genial a friend.

"We think him entitled to rank among the ablest and best of our Palmyra supervisors. We note in his favor the facts that the people especially invited him to accept the office, but did not invite him to leave it. In declining a third term, we congratulate him in finding himself in the illustrious company of George Washington and Theodore Roosevelt."

We therefore direct that the above be inscribed upon the official record of our town. Palmyra, December 28, 1907.

No further business appearing, the meeting adjourned.
