Section 2. If any provision of the local law is inconsistent with any other local law, act, rule or regulation, then the provisions of this local law shall be controlling.

Section 3. This local law shall take effect upon filing with the Secretary of State.

NOW, THEREFORE BE IT RESOLVED, by the Town Board of the Town of Palmyra, Wayne County, New York, as follows:

- 1. That the boundaries of the Stafford Road Sewer District No. 1 within the Town of Palmyra are as shown on Schedule "A" attached hereto.
- 2. That there are no sums to be paid for capital improvement and no bonds are to be issued.
- 3. That the estimated total cost of the Stafford Road Sewer District No. 1 in the construction of the sewer system and/or the acquisition of the land or improvement is zero dollars (\$0) as the improvements will be constructed by the Owner of the real property within the District and thereafter to be dedicated to the Town.
- 4. Pursuant to Section 202 of the Town Law the cost of construction of said Stafford Road Sewer District No. 1 shall be assessed by the Town Board to all the properties located within the District on a Benefit basis.

This Resolution, which takes effect immediately, shall be published in full in the *Courier Journal*, the official newspaper, together with a notice of the Town Clerk.
