January, 22<sup>nd</sup>, 1799 Record of a highway beginning at southeasterly turn in the highway leading along the south side of Mud Creek a few chains easterly of James Galloway's from thence as the needle now points south 75 degrees, east 86 chains, thence south 44 degrees, east 10 chains, thence north 58 degrees, east 8 chains, and 75 links, thence south 35 degrees, east 8 chains and 50 links, thence south 72 degrees, east 12 chains, and 50 links, thence south 40 degrees, east 5 chains, and 50 links, thence south 28 degrees, east 5 chains, thence south 7 degrees, east 72 chains, thence south 1 degree, 30 minutes, east 7 chains, thence south 10 degrees, west 9 chains, thence south 3 degrees, east 12 chains, thence south 12 degrees, east 5 chains, thence south 1 degree, east 9 chains, and 50 links, thence south 9 degrees, east 11 chains, and 50 links, thence south 51 degrees, east 16 chains, thence south 31 degrees, east 18 chains, thence south 22 degrees, 8 chains, thence south 60 degrees, east 2 chains, thence south 80 degrees, east 12 chains, thence east 27 chains, thence south 25 degrees, east 6 chains, thence south 31 degrees, east 6 chains, thence south 45 degrees, east 5 chains, thence east 6 chains, thence north 60 degrees, east 10 chains, thence 13 chains there it intersects the town line a few chains north of the southeast corner. January 16<sup>th</sup>, 1799 Mud Creek established as a navigable stream from the west line of No. 12, 2<sup>nd</sup> Range to the mouth of the same by John Swift and Benjamin Wells. Superintendents of Highways Stephen Phelps, Town Clerk March 11<sup>th</sup>, 1799, a new division of the road districts made as follows: 1<sup>st</sup> Road district beginning in Mud Creek, where the west line of Webb Harwood's land intersects said creek to extend south to the town line and westerly up the middle of said creek to the west line of Lot No. 8, thence south to said town line.

- 2<sup>nd</sup> Road District beginning at the west line of Webb Harwood's land, thence west on the road that leads by John Gilson's to the west line of said town, including all the road south within the limits of said town down to the first mentioned line, excepting what is included in the 1<sup>st</sup> District.
- 3<sup>rd</sup> Road District beginning on the town line west of William Jackway's, thence north on said line across Mud Creek to road laid on the north side of said creek, thence westerly to Webb Harwood's west line including John Swift, Esg. and Nathan Comstock and all the road south to the south line of said town.
- 4<sup>th</sup> Road District beginning at the west line of No. 12, 2<sup>nd</sup> Range, thence easterly on the north bank of Mud Creek until its junction with Red Creek, thence on the south bank of said creek to the west line of Thomas Goldsmith's land, thence down the middle of said creek to James Galloway's west line including all the road to the south line of the town. 5<sup>th</sup> Road District beginning in the middle of Mud Creek as far west as James Galloway's west line, thence down the middle of said creek to the east line of the town including all roads to the south line of said town.
- 6<sup>th</sup> Road District comprises all the roads north of the last mentioned district as far west as William Humphrey's east line.

7<sup>th</sup> Road District beginning at the east line of William Humphrey's and thence up Mud Creek including all the roads north of the 4<sup>th</sup> District as far west as Red Creek and up the west bank of said creek to Thadeus Taft's south line, thence up the east bank of said creek to the town line.

8<sup>th</sup> Road District includes all the roads north of the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> Districts and west of the 7<sup>th</sup>.
