   2. <u>Teleconference notes received:</u> Dave Nussbaumer attended a teleconference session entitled "Town Board and Town Clerks Working Together: Whose Job Is It?" and was so impressed with it that he wanted a transcript of what transpired.    3. <u>NYMIR Underwriting survey and recommendations:</u> An underwriting survey was performed of our municipality. From the Regional Risk Management Supervisor's visit, two recommendations were generated. Both were in the Highway Department. Both recommendations were addressed and corrected the following day.    4. Excellence in Equity Award: The Palmyra Assessor, Elaine Herman, has qualified for the New York State Office of Real Property Services' Excellence in Equity Award. 7. <u>DEC letter about expansion of mining permit:</u> Abram Cleason Co., Inc. has submitted an application to the Department of Environmental Conservation requesting a Mined Land Use Plan Modification on Palmer Rd. Since the Town of Palmyra is an involved agency, the application package was forwarded to us for a 30-day public review and comment period. They also asked the town to consider the selection of DEC as the lead agency for this review. No action was taken at the board meeting concerning this request.

8. Federal Fire Grant Awarded: A communication received today **PALMYRA FIRE** from Congressman James Walsh announced that the Palmyra DEPT. Fire Department was awarded \$129,509 to fund the purchase AWARDED of a new firefighting vehicle as part of FY 2004 funding FUNDS FOR NEW FIRE secured by the congressman for fire service providers TRUCK nationwide. Specifically, this money is to purchase a new THANKS TO 1.000 gallon pumper truck to replace the oldest vehicle in the **CONGRESS**department's fleet. Congressman Walsh is an original co-MAN WALSH sponsor of the program's authorizing legislation.

## **REPORTS OF STANDING COMMITTEES**

# Buildings and Grounds Committee – Kenneth Miller, Chairman

Ken Miller reported snow removal of sidewalks at entrances around the Town Hall has had problems, but are being addressed and solved. Some roof gutters in the back have been reattached. Fascia boards in the back are in poor condition. Reguttering will be required when the roof is replaced. We are now waiting out the winter so the roof repair work can begin.

#### Highway Committee – Michael Lambrix, Chairman

1. <u>Authorization to obtain quotes for purchase of mower</u> <u>attachment:</u> Highway Superintendent Mike Boesel requested authorization from the Board to obtain quotes for the purchase of an Alamo mower attachment. When asked how much was budgeted for the attachment, he said \$7,000 was already set aside in the 2005 budget for this purchase. 2. Authorization to obtain guotes for purchase of plasma cutter for MTN: AUTHORthe shop: Highway Superintendent Mike Boesel requested **IZATION TO** authorization from the Board to obtain guotes for the purchase OBTAIN of a plasma cutter for the shop. When asked how much was QUOTES TO PURCHASE budgeted for the attachment, he said \$4,000 was already set PLASMA aside in the 2005 budget for this purchase. Mike Lambrix made **CUTTER FOR** the motion to authorize Boesel to obtain guotes for the SHOP equipment, not to exceed \$4,000.

3. <u>Authorization to purchase a Bobcat on the State contract:</u> Highway Superintendent Mike Boesel requested authorization from the Board to purchase a Bobcat on the State contract. When asked how much was budgeted for the piece of equipment, he said \$26,000 was already set aside in the 2005 budget for this purchase. Mike Lambrix made the motion to authorize Boesel to purchase the Bobcat on the state contract, not to exceed \$26,000.

4. <u>Contract with auctioneer for Municipal Auction</u>: Handed to each Board member was a copy of a letter from Roy Teitsworth, Inc., Professional Auctioneer, in which he details the terms of the arrangement with the Town for this year's Municipal Auction at the Highway Barns on Saturday, May 21, 2005, at 9 a.m. The Board wanted to know if the Palmyra Community Center will be able to provide the concessions for the auction. Boesel assured them the PCC would be able to do that as a fundraiser. Mike Lambrix made the motion to contract with Roy Teitsworth, Inc. for this year's municipal auction.

#### Planning Committee – James Welch, Chairman

<u>Planning Board letter of resignation:</u> Supervisor Lyon received a letter from William H. Baker, who currently serves on the Town Planning Board. He cites health reasons for requesting his resignation from the board, and for not being able to complete his term, which ends December 31, 2006. In his letter, he states that he "will continue to serve until [there is] a replacement" for his position. For this reason, the town board took no action to accept his resignation. When a replacement is determined and approved, the board expects to officially accept it.

For the record, it was noted that there is an opening in the Board of Assessment Review to fill the seat of Gordon DeMay, whose term expired September 30, 2004, and who chose not to be reappointed. All other board seats, elected and appointed, have been filled.

## Zoning Committee – David Nussbaumer, Chairman

- 1. <u>CEO Report:</u> Bob Grier submitted his CEO report which summarizes activity through January 27, 2005. CEO REPORT FOR JANUARY 2005
- Palmyra Inn update: Grier said the construction has run into some weather difficulties. However, part of the cement floor has been poured and the "stick" construction has started. Already installed are underground electric, gas and water lines, as well as plumbing. Lynne Green showed a copy of the January 14, 2005, edition of the *Rochester Business Journal* to board members. An article on page 3 features the Palmyra Inn.
- 3. <u>Zoning Ordinance update:</u> When asked what project Grier's office would be working on in 2005, he said he plans to "breathe new life into the 2002 zoning ordinance, updating it to conform with the 2003 building code." He has contacted Stu Brown, who reviews such documents from many municipalities, to send the proposed zoning code for review, make changes and recommendations, and to set up the correct procedure and time table for public hearings, etc.

#### INFORMATIONAL ITEMS

- 1. <u>Assessor's Report for January:</u> All claims concerning reassessment have been completed. Exemption forms have been mailed for various tax exemptions in 2005, and the previously-approved laser measuring tool has been purchased, and is doing a great job for Elaine.
- 2. Route 21 Truck Traffic meeting: On January 25, 2005, the local group concerned with the increased traffic on Route 21, particularly in the village, met at the Town Hall. Dave Lyon updated the board on what was discussed. He said the group is using a "multiphase approach" to check into such things as lowering speed limits, funding for an air guality study (particularly from diesel truck emissions), approaching the state for a bypass around the village, and looking at cooperation alternate routes in with neighboring municipalities. He added that Police Chief David Dalton was at the meeting, and provided insight into what his department has been doing concerning this situation.

1. <u>Resolution: Speed Reduction on Newark-Marion Road:</u> Following up on the petition made by Newark-Marion Road residents for lower speed limits, it was found that a formal resolution is needed to proceed to the next step in the process. Mike Lambrix made the motion to approve the following resolution:
