Supervisor Lyon asked Mr. Schroeder to tell the Board about his project. Mr. Schroeder explained that he would like to remove from his property at 2847 Quaker Road two old mobile homes and a couple of sheds and bring in a new double-wide mobile home.

Supervisor Lyon opened the floor to public comment, and asked Code Enforcement Officer Robert Grier if there were setback violations with Mr. Schroeder's plan. Mr. Grier replied there were none, that the lot is large enough. He said the outbuildings may need to be addressed, and that can be done in the stipulations of approval of the Special Use Authorization.

Mr. Grier went on the say the Board could stipulate the immediate removal of one of the old units, and removal of the other old unit upon issuance of the Certificate of Occupancy on the new doublewide unit. He suggested the stipulations include conformance to Town of Palmyra setbacks, a concrete pad under the home, with concrete block skirting and anchors in the concrete pad.

Mr. Schroeder said he had intended to use plastic, then crushed stone under the new home. Mr. Grier replied that method creates a crushed stone pit that holds moisture, and that a concrete pad would be better.

Councilman Michael Lambrix asked to see a map where the new home would be located. Mr. Schroeder does not have a map at this time.
